CFK Africa operates four healthcare facilities: Tabitha Medical Clinic, Lishe Bora Nutrition Centre, Young Health and Wellness Centre, and Tabitha Maternity Home, as well as a community health outreach program to meet the diverse needs of the Kibera community in Kenya. Community Health Volunteers (CHVs) take health education directly to residents' homes, acting as a bridge between the facilities and the community, conducting home-based health screenings, referring residents to clinics for vital healthcare services, and conducting follow-up visits with patients.

4b (Code:) (Expenses \$ **71,752** including grants of \$ **45,370**) (Revenue \$)

CFK Africa supports education both in and out of the classroom, providing young people with opportunities for academic and economic success and development. Through four projects, CFK provides scholarships to cover school fees, identifies cost-effective best practices to improve student attendance and progress, helps students develop work readiness and entrepreneurial skills, and promotes peace, unity, and equality through sports.

4c (Code:) (Expenses \$ **55,974** including grants of \$ **29,592**) (Revenue \$)

CFK Africa supports adolescent girls and young women through a dual strategy of mentorship and advocacy, using male involvement as an auxiliary approach to help promote gender equity. Recognizing females face unique challenges, CFK builds self-agency among program participants, provides them with access to a support and accountability system, and encourages them to develop and use their voices and practice leadership, creating strong sisterhoods. In partnership with the Adelle Onyango Initiative, CFK has developed a long-term group therapy program for survivors of sexual and gender-based violence.
